







## DECLARATION OF THE PROJECT PARTICIPANT<sup>1</sup> on the processing of personal data

Your personal data shall be processed on the basis of art. 6 § 1 letter c Regulation (EU) 2016/679 of the European Parliament and of the UE Council of April 27, 2016 on the protection of individuals due to the processing of personal data and the free movement of such data as well as waiving the Directive 95/46 / EC (General Data Protection Regulation). This implies that your personal data is necessary for the Applicant/Beneficiary to fulfil legal obligations imposed on it due to the implementation of the above mentioned Project. - 7. Your personal data will not be tranferred to a third country or an international organisation.
- 8. Your personal data wll not be subjected to automated decision making.
- 9. Your personal data will be stored for the period necessary to achieve the purposes specified in Art. 87 section 1 of the Implementation Act
- 10. You have the right to access your personal data at any time, as well as the right to request their rectification. However, the right to delete data, the right to limit data processing,

the right to transfer data and the right to object are available in the cases and on the terms specified in Art. 17-22 GDPR.

- 11. If you believe that the processing of your personal data violates the provisions on the protection of personal data, you have the right to lodge a complaint with the supervisory authority, i.e. the President of the Office for Personal Data Protection, ul. Stawki 2, 00-193 Warsaw.
- 12. Providing your personal data is voluntary, although refusing to provide it will result in the inability to participate in the implementation of the Project.
